

## How to protect your content and identify academic integrity violations on Course Hero

We at Course Hero take academic integrity and protecting intellectual property very seriously. Our focus is on helping students learn, complete their courses and ultimately graduate. **Content Discoverability** - We have created the world's largest library of user generated supplemental educational content in a way that is open and discoverable to all. Being open not only helps students find valuable information efficiently, but also makes it easier for educators and institutions to identify students violating academic integrity guidelines (especially compared to offline methods or sites with ill intent). For us, discoverability is key to removing the incentive for students to plagiarize, cheat or infringe on other's rights. This is something we educate students on as they use our platform. As a professor, you can search Course Hero for specific titles or for text from the document using any online search engine like Google.

**Free Access** - Should you find potentially infringing content or content that could represent an academic integrity violation on our site, and you want to use our advanced search functionality, we are happy to provide you with free access to our site.
